SPECIFICATION

VIP Seating

- 20m X 20m free standing marquee with front glass, white in colour, positioned 1/2 m from floor.(Marquee must be clean)
- 6 sets of modern 5 seater lounge suites (Black, red and white colours) with ottomans or modern coffee tables with Centre pieces
- 200 chairs with white chairs covers, 20 round tables with table cloths and centre pieces as well as 8 trestle tables with table cloths.
 - Marquee must be fully draped in cream-white and earth colours with green carpet covering entire marquee.
 - > 45 Outdoor bar type steel chairs and 15 bar tables set and 8 outdoor umbrellas.
 - Decoration of external viewing area-create a full garden and water fountain area covering 5 square meters.
 - > 2 X 20m red carpet.
 - > Lighting to be provided inside the tent.
 - Provide own generator.
 - > Fire extinguisher must be provided inside the marquee.
