Service delivery and forthcoming plans for the year 2022/23

NCE more, we welcome you to our edition that updates you on the progress of the Municipal projects as the Water and Sanitation Authority. This communication tool is shaped up based on the previous completed projects and those underway. However, it also gives light on our forthcoming plans, service delivery progress as per our new financial budget of the year 2022/23.

Apart from that, we inform you about the Municipal programmes meant to capacitate Municipal employees and celebratory events as per their different months and themes.

There have been a lot of workshops aimed at empowering our staff as part of building the capacity of the municipality and ultimately rendering quality services to our communities.

We, the Communications Unit conducted a workshop to educate all employees about communications. Since communication is an integral part of any organizational structure, be it a public or a private entity, it is important that employees are trained at intervals regarding communication issues. Within the public sector, communication is a critical tool of governance which plays a strategic role in determining the quality of service delivery.

Skills Development Act makes provisions for capacity building of employees in any organization. Responding to that call, the Corporate Services Department workshopped business unit managers and their subordinates in all departments on June 2022. Municipal Councillors were also trained on computer literacy. The Water Services Department (Customer Care) also had a Batho Pele Principles workshop where employees were reminded of the important role the Batho Pele (people first) Principles play in service delivery.

As a developmental state, our government adopted eight principles that guide the rendering of services to the citizenry. Consultation is one of the eight principles of Batho Pele in which Harry Gwala employees were trained on. The philosophy behind the principle of consultation

is that people must be consulted on the services to be rendered to them by the government and those services must respond to their needs. If services are not responding to the needs of people, tension is developed between government institutions and the citizenry, and ultimately lead to permanent protestation. It is necessary that employees are capacitated timeously to avoid unnecessary service delivery protests.

As part of the developmental state our government adopted Izimbizo as a citizen engagement strategy. Izimbizo are regarded as the only platform that the government is using in terms of interacting with the public on a face to face basis. We have recently hosted Imbizo in Kromhoek Sports Field, Ward 20, UMzimkhulu Local Municipality where we saw Deputy Minister of Human Settlements, Pam Tshwete together with other Deputy Ministers including Deputy Minister of Mineral Resources and Energy, Dr. Nobuhle Nkabane interacting with the electorate.

We are coming from Youth Month where young people were encouraged through different programmes to be exemplary in their communities and follow the footsteps of heroes and heroines of June 16, 1976 who dedicated their lives for the liberation of South Africa from apartheid. One of the challenges which most of our communities are faced with in this country is the immoral behaviour attributed to young people. We successfully hosted a Behaviour Change Campaign at Ufafa, under uBuhlebezwe Local Municipality. With such campaigns we want to reach as many communities as we can, for moral regeneration purposes.

In conclusion, we urge our communities to cooperate with the municipality by paying their bills. Paying bills does not only clear the ratepayers name on credit matters, but it boosts the municipal revenue which we use to finance the services that we render to our communities. There is an Amnesty Programme provided by the municipality, people are encouraged to make use of it. We humbly appeal to the citizenry of Harry Gwala to use water sparingly.



people, originally from UMzimkhulu, allegedly killed by assailants who opened fire inside a Tavern in Soweto in the Gauteng Province.

We have also held a number of programmes where our District was visited by honourable Deputy Ministers to lend an ear on the ground as part of the District Development Model aimed at fast tracking service delivery in rural areas.

We are also proud to announce that our 2022/23 financial year budget was adopted uncontested with



thorough consultations with the public and the Traditional Authority.

This budget is sound and realistic and allocates expected revenue to achieve core service delivery priorities as set out in the Integrated Development Plan. Furthermore, we have put plans in place which include fast tracking the installation of prepaid meters, removing illegal connections and implementing appropriate debt collection remedial measures.

We are pleased to announce that, through extensive consultations, using various avenues such as provincial/ community radios, social media platforms and community meetings, the people of our District actively participated in the IDP/Budget process. During the presentation of the Medium-Term Budget Policy Statement (MTBPS) in February, Finance Minister Enoch Godongwana, pointed out that our country has more than a decade of economic stagnation. This macro-economic challenge has constantly affected the government's ability to allocate sufficient funding for capital projects. In the main, this negative impact is felt by the poor. This is reflected in the insufficient allocation of conditional grants for capital projects to municipalities such as Harry Gwala, which are facing a historical and longstanding infrastructural backlog.

The situation is worsened by a combination of factors, including that our revenue collection base is generally small, because a lot of people in our District are battling to make ends meet. Another problem which we must never be shy to talk about, is that there are those who, while they afford, do not pay for services they receive from our municipalities. As a government, we have a primary responsibility to provide social services to our communities. Those who receive them, if they can afford them, must pay.

It should be noted that over the past three years we have received the unqualified audit opinions by the Auditor-General which symbolizes responsible and good governance practices. It is imperative that we join hands and ensure that we improve our audit opinion to achieve a clean audit.

Youth Month

We celebrated Youth Day on the 16th of June. We understand the challenges that the youth of today faces but as the District we would like to work together with the youth to achieve their goals. Youth issues are well managed under the Youth Office.

Mr Qiniso Mnguni who is leading the youth office in our Municipality is attending to issues of young people on a daily basis. We encourage all young people to make use of their office.

We also want to congratulate the newly appointed Harry Gwala Development Agency (HGDA) Chief Executive Officer (CEO), Antoinette Whyte for joining us, leaving all the good work she has started in one of our sister Municipalities, the Greater Kokstad Municipality. It is the number one municipality in the province and number nine nationally in terms of being a stable and financial viable Municipality.

ET me welcome our communities to our first publication of the Harry Gwala District Municipal Newsletter for the financial year 2022/2023. As the currently acting Municipal Manager, I would like to begin by providing tribute, gratitude, admiration and honour to our former Municipal Manager, Mrs. A. N. Dlamini, who is no longer in the municipal employ after resignation. Mrs. Dlamini served the District municipality exceptionally well for a period of 20 years and occupied a number of positions during her municipal employment tenure, such as Pims Centre Manager, IDP Manager and Executive Director Economic and Community Services. She also served as an acting Municipal Manager at the then KwaSani Local Municipality, that has since acquired a name change into Dr. Nkosazana Dlamini-Zuma Local Municipality, after the amalgamation process of KwaSani and Ingwe Local Municipality that are two (2) out of the four (4) municipalities falling under the jurisdiction of Harry Gwala District Municipality.

The Executive Director Corporate Services, Miss N. Lungwengwe has also departed from the District municipality after receiving an appointment as a Chief Director: Human Resources Management at the Department of Transport in the Eastern Cape. The Harry Gwala Development Agency (HDA) has recently appointed a new Chief Executive Officer, Ms. A. Whyte who resumed her duty on the 1st of July 2022.

The District Municipality entered into the 2022/2023 financial year with a spirit of renewal and continuation of municipal service delivery. As Local government, our quest is to abide by the Constitution, the local government legislative and policy framework, which creates an amicable situation for municipal compliance to be achieved. The role of the accounting officer is to provide support, guidance and advise to political structures, political office bearers, municipal administration and administrative structures, on governance and service delivery. Section 152(1) (b) of the Constitution prescribes one of the objectives of local government which is to ensure the provision of services to communities in a sustainable manner. This is turn serves as a vehicle for the accomplishment of service delivery.

Our municipality is a water services provider that strives to provide clean, portable water and to overcome the immense water and sanitation backlogs in our rural areas where the majority of our population resides. We aspire as a District municipality, working together with our family of municipalities as a collective, to ensure that there is provision of sustainable services, promotion of social and economic development and the participation of communities in matters that are pertaining to local government.

As a legislative requirement, our municipality operates under the guidance of an Integrated Development Plan (IDP) and the Annual Budget which outlines the key municipal development priorities and service delivery targets. Our budget is structured in such a way that it is geared at meeting our targets respectively. Our Service Delivery and Budget Implementation Plan (SDBIP) has been approved by Council for the current financial year and forms the basis in monitoring the implementation of the municipal budget and IDP. As a District municipality we have always been committed to preparing our Integrated Development Plan in consultation with our communities at the local municipalities using IDP Forums. Communities become engaged in IDP/ Budget Izimbizos to comment and input on our service delivery targets. The publication of the newsletter serves as a communication tool to inform our communities about work that is continuously done by the municipality to meet targets and fulfil the constitutional mandate.

Our Newsletter features the Harry Gwala Marathon which was a huge success and poses to be an on-going year after year event that seeks to put the District on the sporting map. It also boosts the District economically as the attendance and turn out attracted many participants from in and around the District and the KZN as a whole. Seven hundred athletes (700) participated in the different race categories. On traditional leadership, the Harry Gwala District Council has two (2) traditional Leaders that serve and play a role in encouraging that the mission and mission statement of the District is achieved.

Our District adopted the 2022/2023 financial budget at Bulwer under the Dr. Nkosazana Dlamini-Zuma Local municipality during an open Council meeting.

In conclusion, my aspiration as an acting Municipal Manager is to sustain the administrative component so as to meet the requirements of Council and to encourage communities within our District to work together in addressing developmental challenges so that service delivery can be accelerated.





HE Harry Gwala District Mayor, Councillor, Z.D. Nxumalo has called upon different congregations and denominations to always put his District in their prayers due to a number of killing incidents that seek to dominate in the District.

Cllr Nxumalo appealed for divine intervention to descend to the region in the wake of the recent incident where assailants reportedly shot people in a tavern in Soweto in the Gauteng Province, leaving 13 victims dead which were originally from UMmzimkhulu.

The memorial service, held in UMzimkhulu recently, was attended by the KwaZulu-Natal Premier Sihle Zikalala where the sounds of crying family members echoed around the packed hall.

The memorial service was held at eSayini TVET College in uMzumkhulu with heavily armed police surrounding the hall.

Cllr Nxumalo said it was sad to learn that the victims went to Johannesburg to look for jobs as his District is part of the Districts that have a challenge of job scarcity.

"This is a clear indication that we must all take the issue of the lack of jobs seriously so that we reduce the number of people leaving rural areas to urban areas to hunt for opportunities to feed their families. We need to create an environment that people move from rural to urban areas out of their own will not because they go to other areas to look for opportunities," said Cllr Nxumalo.

He said his District is rich in agriculture but it is only a few people who benefit from utilizing the land, adding that the District Municipality is making strides to ensure the youth gets into the agricultural sector.

He said as the District, they are zooming into the electricity crisis, which leads to power outages owing to loadshedding that also cripples their gradually growing economy as local businesses get affected dearly.

"We are now looking at ways to generate our own electricity but that would be done in line with the laws of the country to check where our Municipality could have the kind of capacity that would be required when we do the research," said Cllr Nxumalo.

He added they have not experienced such mass deaths since 2017 and such incidents came to an end after they held District-wide prayers, meaning the Almighty was on their side and now they need to pray regularly. He said this happens while the District was still mourning the deaths of those that perished in the recent taxi accident, which claimed about 20 lives and most victims of the accident were from UMzimkhulu.

Nxumalo said it was very sad that the victims went to Johannesburg to look for job opportunities so that they could take care of their families, but came back in coffins.

Premier Zikalala, said this was one of the most "extraordinarily painful" incidents that the people of KwaZulu-Natal have suffered.

"We have the KZN liquor authority whose jurisdiction is in KZN, notwithstanding that this happened in Gauteng. We will continue to tighten and enforce regulations that taverns close on time. There are prescribed times for all taverns to close. It does not only expose people to killings but even to social instability because it affects entire communities," Zikalala said.

Harry Gwala Marathon set to be a major economic boost

HE Harry Gwala District Municipality is confident that the marathon, held recently, will grow from strength to strength and is set to be a major economic boost for the district following a promising turn up, which attracted a number of athletes participating in the race that left the local and provincial leadership excited.

The Harry Gwala District Mayor, Councillor, Z.D. Nxumalo was convinced that the marathon would have been far without the two-year Covid- 19 recess, which also affected many sponsors due to the economic slide and recession, which in turn had negatively impact to most businesses.

"I am very excited that after gatherings were prohibited in order to conform to the COVID-19, people showed a huge interest in taking part in the race wirh utmost excitement and interest with the return of the marathon with businesses also coming together promising support going forward," said Mayor Nxumalo.

However, this year's race saw about 700 athletes taking part with a very strong competition in three different categories of the race that were as follows: 42, 2 km, 21 km and 10 km.

The 42,2 km race started from highflats in Ixopo to uMzimkhulu while the 21km started in Ixopo to

uMzimkhulu and 10km started between iXopo and uMzimkhulu.

The Department of Sport, Arts and Culture in KwaZulu-Natal was the major sponsor with the hope that even the private businesses will also play a pivotal role in next year's installment of the marathon.



The MEC Mavimbela echoed Cllr Nxumalo's sentiments that "it was very exciting to see people coming in large numbers in support of the marathon after hard times owing to Covid-19". She said this is part of supporting the local business, whose normal operations were disrupted by the Covid-19 regulations and negatively affected their daily income/profit.

"We want to explore all avenues to ensure businesses go back to normal and continue to play a pivotal role in job creation," MEC Mavimbela said. She said apart from boosting the local business, the marathon can also be a weapon towards boosting local tourism.

A young man from Northern KwaZulu-Natal, Ayanda Ngcobo registered his name amongst the winners as he won the 42, 2 km race, walking away with a R50 000 prize, Ndumiso Sokhela took the second position while Tommy Skink came in third position.

Ngcobo said he had worked very hard to win the race to prevent it from being won by athletes that originate from other countries as it was previously won by an athlete from Lesotho.





He said his win also represents the District of Harry Gwala as part of the KwaZulu-Natal province. In the female category race, the 42.2 km was won by Jennifer Koech from Kenya. Makhosi Mhlongo took the second position followed by Lisa Collett.

The Mayors of different Municipalities, UMzimkhulu, uBuhlebezwe and Dr Nkosazana Dlamini-Zuma Municipalities congratulated the winners.

Harry Gwala District Mayor, Councillor, Z.D. Nxumalo, Council Speaker, Councillor, S. Mdunge and the Acting Municipal Manager, Thobile Thiyane- Magaqa were part of the open council meeting and played a role in giving answers to the questions raised by the observers and stakeholders.

HE R865,7 million total budget for the year 2022/23 was adopted by the Harry Gwala District Municipality Council recently.

The 2022/23 financial year budget was adopted in Bulwer under the Dr Nkosazana Dlamini-Zuma Local Municipality, which was attended by the relevant stakeholders that also believed the budget talks directly to community challenges on the ground.

During the budget adoption, it appeared that the R600 million Bulwer Dam is compelling the Harry Gwala District Municipality to allocate a huge chunk of its capital budget to the Dr Nkosazana Dlamini Zuma Local Municipality for its implementation.

This came to light after the Harry Gwala District Municipality Mayor, Zamokwakhe Nxumalo, while tabling the budget, indicated and and clarified why the Nkosazana Dlamini-Zuma Local Municipality seems to be getting the biggger slice of the District's budget, compared to other local municipalities.

The Bulwer Dam will be funded by the national Department of Water and Sanitation, as it is meant to be a backup and a permanent water solution within the District. It will supply water to the neighbouring Districts as well such as Ugu.

This is set to yield savings on the part of the District Municipality as the municipality rents dams from the neighbouring farmers as backups during dry seasons.

Speaking at Bulwer Hall on the 27th of May during an open Council meeting, Nxumalo said the project would

start before June next year.

"This forms part of our projects to shape up local projects in preparations that would accommodate other projects in the pipeline," said Nxumalo.

He added that negotiations for the project have received the green light from the national government and are at an advanced stage.

He revealed that this is a mission to ensure that they become the leading District in terms of water supply in the country since they also have plans to have a water testing/treatment plant in the District where they will not depend on Umgeni Water to test the status of their water.

Opposition parties commended the budget adoption but the Democratic Alliance disputed the six percent tariff increase.

The Mayor said, "Despite being a grant funded Municipality, we are too rural... we do not have a viable revenue collection as the Municipality is owed R239 million by the communities in terms of rates". The DA added the rates should be fair, bearing in mind the Municipality's background and the current financial situation.

Nxumalo said they want to collect at least 40% of the outstanding R239 million debt. The capital budget allocation to municipalities as per the division of revenue act is as follows: The Greater Kokstad Municipality (R35 million), uBuhlebezwe (R70 million), UMzimkhulu (R101 million) and Dr Nkosazana Dlamini-Zuma (R113 million).





HE Speaker of the Harry Gwala District Municipality, Councillor Sibongiseni Mdunge has appealed to the private sector not to take a backseat when it comes to finding solutions to community challenges but they should also join hands and help by donating any assistance that might help put food on the table for the needy.

Cllr Mdunge made this call when he visited a family of fourteen family members living in a two bedroom house, in an unbearable and not conducive situation in uMzimkhulu where they also donated groceries.

The family was identified during campaigning programmes for the previous elections and was further profiled to follow all the processes.

It was discovered that the fourteen children live in a two-room house and the other family of five children was also living alone with nothing on the table.

The Speaker, Cllr Mdunge, together with the Disaster Unit in the UMzimkhulu Municipality bought groceries for the families. The family depends on government grants to put food on the table.

"It should be noted that the groceries we brought will not last long and it is because of this reason why we are calling upon the private sector to come forward and assist the families," said Cllr Mdunge.

He said their dream is to build a shelter for both families but will continue to consult businesses to donate whatever they can to accomplish their wish of seeing these families living in proper houses.

This further touched a 45-year-old woman who could not hold back her tears saying: "it is very painful to see young kids going to school without food". She thanked the Municipality for the support, hoping that it was not going to be a once off thing.

"With the recent floods we couldn't even sleep because the house is not strong, water was leaking. We would like assistance with a house and jobs for us so we can provide for the family," she said.

with the management on sites to ascertain as to what could be done in order to fast track these projects and to be sensitized about where there is a need to unblock or unchain some of the challenges raised regarding these projects.

The Mayor said it was important to go on site visits and brave the cold weather to ensure that they as the Municipality do not only rely on reports written by engineers or municipal officials about the progress on the municipal funded projects but they should physically go to the projects to witness whether what is written on reports coincides with what is on sites.

"As leaders, we should not be office or desk bound but we should regularly go out to observe the projects on our own. This does not mean we do not trust the reports from the officials but it is part of our jurisdiction in relation to the oath of office we took that we shall remain public servants at all costs," Cllr Nxumalo said.

He added the visits were very useful because they are able to intervene where there are challenges resulting in a slow pace or backlogs on certain projects.

Whyte graduated - Cum Laude - from the Institute of Business Management with a National Diploma in Business Management and has a qualification in BA, Majors in Development Studies and Political Science from UNISA and from the University of Pretoria she obtained an NQF 6 in Executive Leadership Development Programme and from WITS she passed the NQF6 - Certificate Programme in CPMD. She is currently studying towards her LLB also at UNISA.

Her most recent experience is evidenced in having institutionalised, managed and grown the Local Economic Development Unit of Greater Kokstad Municipality, which was inclusive of championing the Smart City Development Strategy of Kokstad, realising increased investment of approximately R147 million in a period of five years, creating in excess of 2000 work opportunities through the Expanded Public Works Programme (EPWP) as well as an oversight of the SANRAL led Kokstad N2 Interchange, SMME business retention and expansion, together with growth in the agricultural sector through municipal led projects, the most notable being the Franklin Hydroponic Tunnel project which has secured commercial off-take arrangements.

He also addressed the issue of census that its workers should be allowed to count the people as it would be to the government's advantage to know the number of the people in the country and the statuses of communities as to how many graduates are sitting with degrees at home and how this challenge would be dealt with.

"We want to hear what development you want to see, who needs water and our services in your communities. In such meetings we then discuss ways of improving where it is necessary to do so," said Cllr Nxumalo.



BATHO PELE WORKSHOP



The Municipality has identified the need to conduct a two-day Batho Pele workshop designed for municipal employees.

The workshop was held on the 21st and 22nd of June 2022. The workshop focused on how to make Batho Pele a reality in the workplace, and to ensure the alignment of Batho Pele Principles into the Municipality's work plans.



Furthermore, the workshop will assist the employees to restore old skills and knowledge of Batho Pele Principles.

During her opening remarks, the Acting Municipal Manager Mrs. T.T. Thiyane – Magaqa highlighted that Batho Pele was not a stand-alone concept, however, the principles are means to enhance service delivery.

SPRING PROTECTION PROJECT

Background

The Harry Gwala District Municipality (HGDM) is one of the Water Service Authority (WSA) municipalities in the KwaZulu-Natal province. The HGDM consists of four local municipalities (LMs); namely uBuhlebezwe, UMzimkhulu, Greater Kokstad and Dr. Nkosazana Dlamini-Zuma LMs that are categorized as water services areas in terms of water service provisioning. Most rural villages in the Harry Gwala District Municipality still depend on standalone water supply schemes that provide an interim supply of potable water to the communities whilst the municipality implements multi-year projects which intend to provide bulk potable water from reliable sources.

The Harry Gwala District Municipality developed a business plan to be funded under the Accelerated Water Intervention Programme that was submitted to the provincial Department of Co-operative Governance and Traditional Affairs (CoGTA) to solicit funding for the 2021/2022 financial year. The primary objectives of the business plan was to address water shortages and relieve the backlog that the District is faced with in the provision of access to basic water services.

Intervention

The District earmarked on the development of water springs protection to address the water challenges faced by the District as per the Provincial Water Masterplan developed by CoGTA. The District appointed a contractor to address the aforementioned challenges.

All tender procurement processes were followed on the appointment of the contractors;

 Mthuthukiswa Construction Pty Ltd was appointed for the universal spring protection for the villages of UMzimkhulu, Dr. Nkosazana Dlamini-Zuma, and uBuhlebezwe Local Municipalities, under contract number: HGDM757/HGDM/2022.

Scope of Work

The scope of work for the universal spring protection entailed the construction of v-boxes, installation of a 5 000L static storage tank, construction of a water connector pipeline from the v-box to the storage tank, and the installation of the standpipe, water spring fencing, and installation of a pedestrian gate.

The construction of the aforementioned projects has been completed and the below communities are benefiting from the program.

WSIG PROJECTS

PROJECT OBJECTIVES

The primary objective of this programme is to ensure that the population of the Harry Gwala District Municipality is relieved of the stress resulting from a lack of potable water supplies, which are reliable and of acceptable quality. This is through the supply and installation of intervention water supplied through funds supplied by the Department of Water and Sanitation under the Water Services Infrastructure Grant (WSIG). WSIG must serve extensive areas over Municipal jurisdiction with the main aim to eradicate backlog, fast-track service delivery as well as water demand and conservation management.

BACKGROUND:

The Nokweja water supply scheme is made up of 19 villages. The water supply scheme is subdivided into 12

zones (namely Reservoir B to Reservoir F, Res 2 to Res 8) based on the elevation and the main water supply reservoirs servicing the scheme. Nokweja water supply scheme has water resource, and maintenance challenges on the existing bulk distribution network, and as such, water does not reach certain villages within the water supply scheme. Thus, this project focuses mostly on the short-term interventions to address the immediate water shortage challenges in zones E and F, which encompasses Nokweja, Ramaphosa, Nongongonini, Nkomeni, Two thousand and Mawusheni villages. Two boreholes equipped with hand pumps were identified in Nokweja and Nongongonini villages and earmarked for the project. ZCE appointed a geo-hydrology to conduct a yield test to establish the available yields and water quality of the two boreholes. The two boreholes were found to have sufficient yields to meet the current water needs of the two zones (E and F) in the Nokweja WSS scheme at a level of service of 25l/d/ca. The project will serve 816 beneficiaries. Due to the delay by Eskom with the installation of power, the project was delayed. Currently, we install diesel generators for operational purposes. Both pump houses have separate generators.

The current scope of this project is to alleviate the problems currently experienced in raw water from the UMzimkhulu River.

BACKGROUND:

The Masamini Mbuzweni Water Supply Scheme is formed by seven (7) villages namely (Sangweni, Rauka, Nonginqa /Nkukhwini, Nqokozweni, Dumisa, and Myembe), which all fall under UMzimkhulu Local Municipality (ULM) which is one of the four local municipalities that fall within the HGDM. UMzimkhulu Local Municipality is mostly rural and dominated by traditional land ownership. The area has about 90.8% of the population residing in rural areas, while the remaining 9.2% are urban-base. Hulu is a town in Harry Gwala District Municipality in the KwaZulu-Natal province of South Africa. The UMzimkhulu town lies 243 km north-

east Mthatha and 18 km south-southwest, it borders the outskirts of Drakensberg mountain ranges near Ward 1 of UMzimkhulu LM.

The beneficiaries of this project are about 11 200 people covered by the seven (7) villages. The reason

behind the implementation of this project was to cover the huge backlog of proper consumable water by poor communities of UMzimkhulu LM.

One below shows a 20-year population projection per village from 2020 to year 2040.

The findings of the investigation of this project had proven that these villages have infrastructure that is aging or inadequate or no water supply sources, lack of infrastructure, and in most instances unprotected and unsafe water sources to be consumed by humans, also most people walk long unreasonable distances to fetch water.

Now this project has assisted the people residing in these communities by providing them with proper infrastructure and safe water, which they get within a 200m radius from their homes. Even for the elderly people it is now easy for them to be able to get water on their own because now the water is nearer to their homes.

All the junctions and standpipes have installed linearmotion isolation valves with the ability to either stop or allow flown in cases of emergencies like a broken tap and a pipe leak used to isolate specific parts of the water supply network for maintenance, repair, and new installation operations, as well as to reroute water flow throughout the pipeline.

PROJECT BRIEF

UMzimkhulu Local Municipality is predominantly rural in nature with a high unemployment rate and many people living below the poverty line. At present people within the area of study in the local municipality depend on natural sources like streams, rivers, and springs for their potable water supply. Water in many areas is not purified and this makes these areas exposed or prone to cholera and other waterborne diseases. The quality of water is generally poor. Water from the main pipeline supplies and from the boreholes is not always in working order. Most of the existing water distribution networks are below the minimum level of services, thus people often have to fetch water outside the stipulated 200m radius from their place of residence.

EXECUTIVE SUMMARY

The proposed scope of works and implementation plan for the seven (7) villages proposed in this report will be conducted as part of phase 1 of the project while the rest of the remaining villages will be catered for as part of phase 2 of the project based on the availability of the budget. The seven (7) villages considered in this report are in the jurisdiction of UMzimkhulu Local Municipality (UMzimkhulu LM is one of the four local municipalities that fall within the HGDM). UMzimkhulu Local Municipality is mostly rural and dominated by traditional land ownership. The area has about 90.8% of the population residing in rural areas, while the remaining 9.2% are urban-based. The population of the seven villages under study in this report is about 11

200 people. According to the 2018 Harry Gwala WSA: WSDP-IDP Water Sector Input Report, UMzimkhulu Local Municipality has the second highest number of water supply backlogs of 11 094 households compared to the total number of 34 287 of the entire Harry Gwala District Municipality.

AMNESTY PROGRAMME

The Harry Gwala District Municipality Mayor Cllr. Zamo Nxumalo encourages all residents to use the amnesty programme provided by the municipality to pay for services.

From June the Municipality has been implementing an Amnesty Programme with the intention to reinforce the culture of payment for municipal water and sanitation charges.

In light of the above, Harry Gwala Disrict Municipality has resolved to offer amnesty to water and sanitation customers whose accounts are 180 days or more in arrears. The qualifying customers who wish to benefit from the amnesty will have to come to the municipality's offices, either in Ixopo, Umzimkhulu or Kokstad, to obtain amnesty application forms, which upon completion, must be submitted to the same office. The closing date for the amnesty is the 30 September 2022.

Mayor Nxumalo said: "Customers

are encouraged to make use of this amnesty opportunity. If you are not sure what to do, go to our offices and you will get an explanation," said Mayor

The amnesty shall be administered as follows:

- 1. Accounts of which 50% of the overall debt are paid within 30 days after the signing of the amnesty application forms will be written off by 50% of their outstanding debt.
- 2. Accounts of which 50% of the overall debt are paid within 60 days after the signing of the amnesty application forms will be written off by 40% of their outstanding debt.
- 3. Accounts of which 50% of the overall debt are paid within 90 days after the signing of the amnesty application forms will be written off by 30% of their outstanding debt.
- 4. Accounts of which 50% of the overall

debt are paid within 120 days after the signing of the amnesty application forms will be written off by 20% of their outstanding debt.

- 5. Accounts of which are paid 50% of the overall debt are paid within 150 days after the signing of the amnesty application forms will be written off by 10% of their outstanding debt.
- 6. Qualifying customers who are unable to take up the amnesty offer in terms of the above cited five (5) categories are offered to make debt payment arrangements with the municipality, subject to terms and conditions stipulated in the debt arrangement form obtainable from the municipal offices in Kokstad, Umzimkhulu or Ixopo.
- 7. Customers are encouraged to make use of this amnesty opportunity.8. The amnesty excludes Municipal Councillors, government departments and state owned enterprises.
