- Training manual and material.
- The appointed Service Provider/s will be required to submit training manuals prior to training taking place.
- Duration of training: five (5) days.
- Facilitation of the programme.
- Assessment and moderation of learners.
- Certification of competency for learners.
- Roller ride on for the training
- Proof of accreditation with the relevant SETA for the specific required unit standard/qualification.
- Proof of appointment letters or reference letters for rendering similar service
