### ADVERTISEMENT

#### CALL FOR APPLICATIONS FOR PERSONS TO SERVE AS MEMBERS OF THE MUNICIPALITY'S BID APPEALS TRIBUNAL.

Harry Gwala District Municipality is in the process of appointing members for the Municipality's Bid Appeals Tribunal, which will consider objections against supply chain management related decisions made by the municipality. The Municipality's Bid Appeals Tribunals will consider all bids advertised in the last 6 months.

The Municipality's Bid Appeals Tribunal will be established in terms of the Municipal Finance Management Act (56 of 2003) and its related Municipal Supply Chain Management Regulations (2005). The Tribunal will consist of a Chairperson, Deputy Chairperson, and not fewer than three (3) additional members.

#### REQUIREMENTS:

- Be a South African citizen.
- Be in possession of a tertiary qualification in SCM, Law or Commerce, admission as a legal practitioner will be an added advantage.
- Knowledge of Supply Chain Management requirements prescribed by National legislation, in particular the Municipal Finance Management Act 53 of 2003 and Preferential Procurement Policy Framework Act
- be in possession of a tertiary qualification in SCM, Law or Commerce
- Must be of good standing.

Preference will be given to applicants with experience in the municipal environment.

**DISQUALIFICATION:** The following persons are not eligible for appointment as a member of a tribunal: • an employee of any organ of state • a member of Parliament • the National Council of Provinces • Provincial Legislature • any Municipal Council • a person who is not qualified for appointment as a director of a company; a person who is disentitled in law to hold the office of trustee; and a person who has been convicted of a criminal offence committed after 27 April 1994 and sentenced in imprisonment without the option of a fine.

**TERMS AND CONDITIONS:** Appointment will be on part time basis for a period of three (3) months, but subject to a possible further term not exceeding three (3) years. The employment conditions and remuneration of members shall be determined by the Accounting Officer.

Applicants should send detailed Curriculum Vitae which should include the following information: identity number, gender and race, telephone number, telefax and email address, qualifications/field of study, current and past services on any tribunal or board experience, knowledge and skills, and the names of two contactable referees. Applications that do not comply with these instructions will not be considered.
