SECTION B SCOPE OF WORKS

INTRODUCTION OF THE PROJECT

THE SCOPE OF WORKS ENTAILS SUPPLY AND DELIVERY OF WATER AND WASTEWATER TREATMENT CHEMICALS TO HARRY GWALA DISTRICT MUNICIPALITY FOR A PERIOD OF 36 MONTHS.

1. SCOPE OF WORK

In awarding this Tender, Harry Gwala District Municipality expects the Services Provider to be responsible for following:

Item	Description of work
1.	Supply and Delivery of Chemicals for Water and Wastewater Treatment
1.1	All Treatment Works Chemicals supplied to be SABS Approved.
1.2	20% Mark up to be proposed over items that are not "stock items" with the service provider.
1.3	The rates supplied will be fixed for the duration of the contract.
1.4	The order will be "as and when required" and the service will have to be executed within 24hrs.
1.5	Record of Experience with traceable references

2. SPECIAL CONDITIONS:

- 2.1 Service Provider information should be registered to Harry Gwala District Municipality Database.
- 2.2 Service provider must have previous experience in projects of similar nature.
- 2.3 No costs, apart from the costs specified in this document, will be accepted or allowed to be charged to either Service provider, the Service Provider must ensure that all other costs are covered in the tender.

3. LIABILITY:

Council will in no way be liable for any loss, injury or damage which may be sustained by the successful Bidder, his employees, his equipment or any other person through handling or use of the items offered for sale.

Bidder must follow the Workmen's Compensation Act No. 30 of 1941, for all workmen employed in the contraction process.

All machinery used by the Service provider must comply with the regulations a specified in the Machinery and Occupational Safety Act No. 6 of 1983 as amended.

4. INSURANCES REQUIRED

The Supplier shall submit within seven (7) days from date of receipt of the Provisional Letter of Acceptance, to the Head: Supply Chain Management, the following Insurances and Surety:

- Third Party Insurance to the value of R1 000 000.00 (for any single claim) for any damages to private property/persons arising out of this contract. The policy must be in force for the full duration of the contract period. For any single claim.
- Works Insurance to an amount of the total tender amount.
- Further to the above, the supplier shall indemnify the Council and its employees and agents against all losses and claims for injuries or damages to any person or property whatsoever which may arise out of the execution of this contract.
- When the Head: Supply Chain Management is, in her absolute discretion satisfied with the above arrangements, a Final Letter of Acceptance will be forwarded to the Supplier, confirming that the tender and the letter constitute a binding agreement between the Contractor and the Harry Gwala District Municipality.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
