SCOPE OF WORKS

PROJECT RATIONALE

Bids are invited for the appointment of a panel of training/ skills development providers for the provision of training to Harry Gwala District Municipality employees and councillors for a period of Thirty-Six (36) Months. Service providers should be accredited by the relevant SETA, QCTO and CETA in line with the type of training to be provided. The training shall take place at Harry Gwala District municipal jurisdiction and pricing should include all costs associated with the provision of training. The project is 80/20 and price preference and functionality shall be used.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

**SECTION H
CERTIFICATE OF INDEPENDENT BID DETERMINATION**

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
