#### M.3 Bidder Submission Requirements

#### M.4 Adjudication Criteria

Adjudication criteria will be clearly stated in the bid documents.

The reasons for deviating from the prescribed norms and standards must be documented by the bid adjudication committee and reported immediately to the Accounting Officer.
