SECTION B SCOPE OF WORKS

INTRODUCTION OF THE PROJECT

THE SCOPE OF WORKS ENTAILS: TAKING OF WATER AND WASTEWATER SAMPLES AT PREDETERMINED SAMPLING POINTS WITHIN THE HARRY GWALA DISTRICT MUNICIPALITY, PRESERVING THE SAMPLES ACCORDINGLY WHILST TRANSPORTING THEM AN ACCREDITED LABORATORY FOR ANALYSIS. SAMPLERS ARE TO CONDUCT OPERATIONAL SAMPLING IN EACH SAMPLE SITE. THE CONTRACT WILL BE AS AND WHEN REQUIRED BY THE MUNICIPALITY FOR THE PERIOD OF 36 MONHTS.

1. SCOPE OF WORK

In awarding this Tender, Harry Gwala District Municipality expects the Services Provider to be responsible for following:

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:


