- Works Insurance to an amount of the total tender amount.

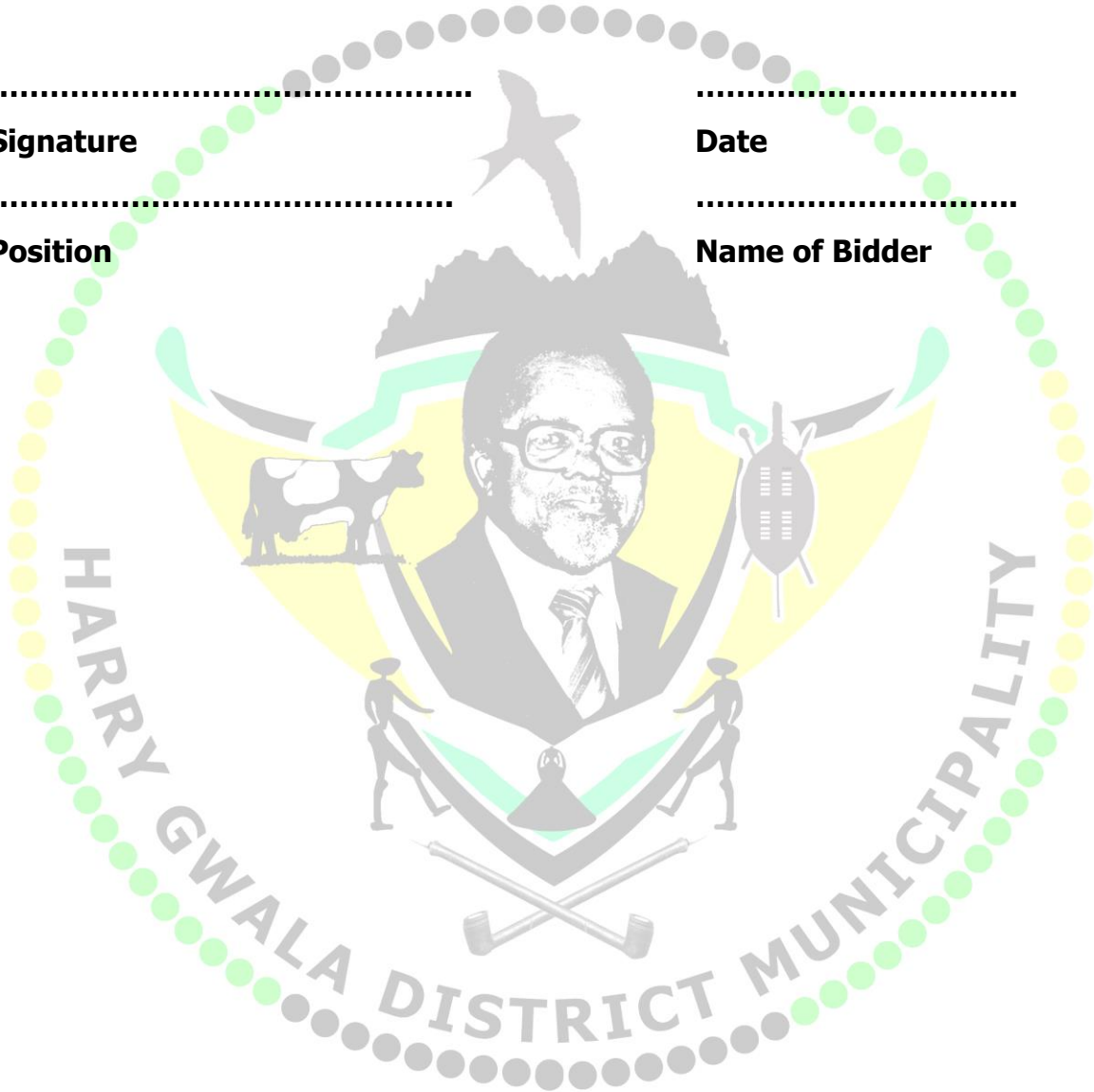

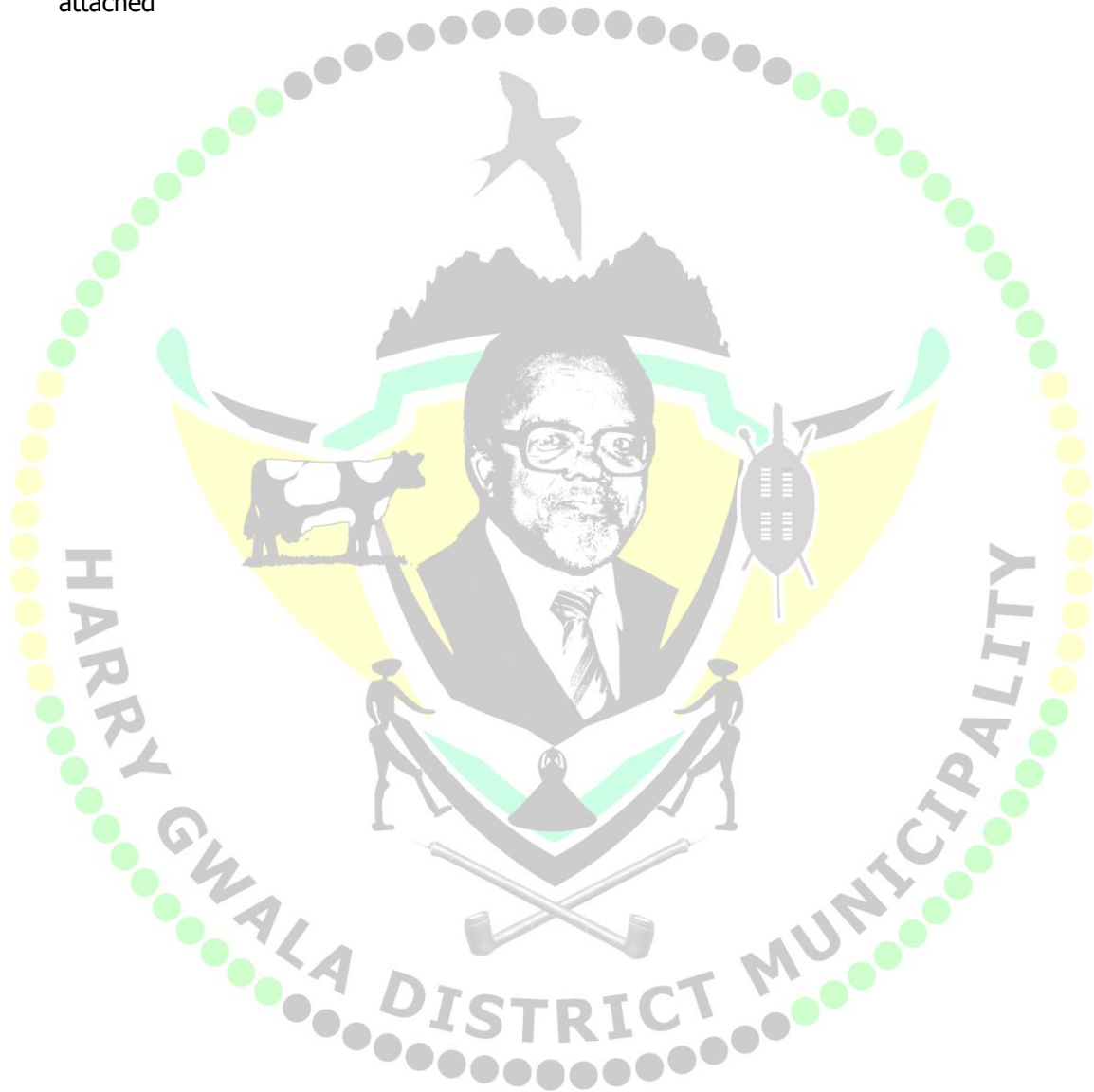
