SPECIFICATION

The Service Provider should provide the following services:

- The verification must be against external data sources to determine the authenticity of the Indigents on the current register (approximately 3000 accounts).
- Access to the following:
 - Department of Home Affairs – Full names, identity numbers and deceased.
 - Credit activity – Credit bureau.
 - SASSA – Pension payments and dependents.
 - UIF – Employments UIF paid over.
 - Deeds office – Property ownership and multiple properties.
 - Directorships - Company ownerships.
- All councillors, three spheres of Government and private sector employee’s verification against register (list to be supplied by client).
- Preparation of excel reports for submission to client that meets criteria according to HGDM Indigent Management Policy outcomes as per area.

Invalid or non-submission of the following documents will lead to immediate disqualification of the tender:

- Valid tax clearance certificate or SARS pin.
- Central Supplier Database Registration

The following conditions will apply:

- Prices quoted must be firm and must be inclusive of VAT (if applicable).

- A signed MBD4 form must be submitted with a price written quotation (available on our website and reception)
